PLAYER & PARENT CODE OF CONDUCT

Failure to do so may result in immediate expulsion from the event without compensation or refund.

1. Participants are expected to conduct themselves in a manner that honors the game and demonstrates respect for other players, coaches, officials and spectators.
2. Performing, permitting, encouraging, or condoning actions that are dangerous or demeaning to a player, coach, official or spectator is unacceptable.
3. Participants are not permitted to be in the possession of or under the influence of alcohol, drugs, and/or tobacco products. Participants are not permitted to be in the possession of weapons.
4. Participants are expected to wear all of the necessary and required equipment for participation in lacrosse.
5. Participants are expected to report any and all injuries to a member of the coaching staff.
6. Participants are expected to treat all Baggataway Camps/Junior Riptide Lacrosse facilities with respect. Baggataway Camps/Junior Riptide Lacrosse will not tolerate any actions of vandalism or actions that result in damage to property.
